






4. The Committee has received advice that the **Rifles War Memorial** is a war memorial by virtue of the War Memorials Act 1923 ("the Act") and under the terms of the Act, as the Committee was responsible for the creation of the **Rifles War Memorial**, the Committee is the lawful owner until such time as ownership is formally transferred.







